The applicant is deemed to have accepted the Water and Sewerage Company Inc.'s terms and conditions appropriate to the service provided as a result of this application.

I/We agree to pay on demand the full fees applicable to the services provided by the Water and Sewerage Company Inc., including all reconnection fees before service is reconnected after being temporarily disconnected for arrears or any other cause, for which the Company is not responsible. I/We agree to pay for the cost of reinstating the meter and / or service line should they be damaged by any party other than the Company's official. (The term "damaged" means the deliberate removal of the meter, the destruction of the meter and / or the line and the burying of the meter by gravel or concrete in such a way that it cannot be retrieved too costly to retrieve. Failure to pay may result in this Agreement being used to create a caution on the said property.

I/We understand that I am/we are bound by this agreement as long as the service line from the property is connected to the company's mains and for periods of temporary disconnection until the service is terminated by giving one month's notice in writing.

I/We agree that there will be no re-imbursment of any fees paid to acquire this new connection or will I/we be allowed to relocate this connection upon termination of my tenancy/ownership.
